



Waiver for Private use of the Extreme Ballroom Studios for Minors

This waiver is specifically for high-school aged students 14-17 years old to be allowed to use the Extreme Ballroom studios for ballroom practice only from 8am – 9pm, Monday through Saturday. After 9pm, no dancers are allowed in the studio without an adult present or on the premises. This waiver is only for those dancers who have an active Extreme Ballroom practice membership.

I am the parent of _____ and I acknowledge that my dancer has an active monthly Extreme Ballroom practice membership. I give my permission for my high school student to be allowed to use the Extreme Ballroom Studios for ballroom practice even if an adult or coach isn't on the premises. I understand that if any injury or accident happens, there will not be an adult there to help, and I waive any responsibility that might be put on Extreme Ballroom Company as well as Tim and Staci Huston. I acknowledge that the only activity my child should be doing is ballroom practice and that any horseplaying, sexual conduct, going into the front desk area, entering Staci's office, or touching or messing around with anything outside the normal ballroom practice items (speakers, bathrooms, fans, etc) is prohibited. I have signed and understand the Junior/Youth Contract, and if my child is acting in a way or touching anything that is against the rules of the studio (refer to the junior/youth contract), Staci Huston has the right to refuse them private access to the studio or to remove them from the company, whichever she deems fit. I understand that my dancer is not allowed at the studio past 9:00pm on any day if an adult is not present. I also understand that it is not my privilege to share the studio code to the front door or Pit with anyone but my dancer who will be using the studio for private use.
